Law Enforcement Training Tuition
(Revised-effective upon Council approval)

Basic Training Academy..... \$6,240.00

(The total cost of the Basic at ILEA is \$9360.00 ILEA will bill 2/3's of the total costs to the law enforcement agency (\$6240.00). The agency can require the officer to pay 1/3 of the total costs (\$3,120.00). It will be up to the agency to decide and to collect the money from the officer.

Physical performance fee for unsuccessful applicants..... \$125.00

Level I and Level II Basic Training Schools Administrative Fees..... \$125.00/per student

If an officer's department has registered an individual to attend a Basic Training Class and the officer does not attend, a \$125.00 fee will be billed to that department.

In the event an officer attends any part of the Basic Training Class and for any reason cannot complete the class, that officer's department will be billed according to the following schedule:

- For attendance through part of or all of the first week:
.....\$125.00 administrative fee, plus 20% of the total fee for the class
- For attendance through part of all of the second week:
.....\$125.00 administrative fee, plus 40% of the total fee for the class
- For attendance through part or all of the third week:
.....\$125.00 administrative fee, plus 60% of the total fee for the class
- For attendance through part or all of the fourth week:
.....\$125.00 administrative fee, plus 80% of the total fee for the class
- For attendance through part of or all of more than four weeks:
-100% of fees.

In the event an officer is injured so seriously during training that completion of the Basic Training School becomes impossible, fees will be adjusted on a pro-rated basis. If payment for the officer has already been received by the Academy, an appropriate credit will be issued to the department.
